FSN Receives Western Security Bank's Hands of Hope Campaign

Recently, Family Support Network (FSN) was honored to receive \$10,000 from Western Security Bank's Hands of Hope Campaign. These funds plus a matching gift from an anonymous donor will allow FSN to purchase newer model vehicles with high safety ratings as well as extended warranty protection through a local car dealership.

Family Support Network has experienced a 23% increase in families whose children have been removed



from the home for abuse and neglect. Removal of children often involves issues stemming from substance abuse especially methamphetamine. This increase has necessitated a greater reliance on staff vehicles to transport the children for visits with their families. The high number of miles our staff place on their vehicles often necessitates car repairs. The repair downtime can

result in visits being canceled. With the generous award from Western Security Bank, FSN will be able to ensure that visits are not canceled because of vehicle repairs.

These visits are critical to negating the issues of powerlessness, fear, anger and abandonment felt by children being removed from the only home they have known. Studies show that successful reunification efforts hinge on keeping family relationships viable through frequent visits and providing strong programs such as the programs conducted by FSN to teach parents the necessary skills and parenting techniques that help provide a safe nurturing environment for their children.

As part of our "Hands of Hope Campaign" the management and staff of Western Security Bank are proud to assist in the important work of the Family Support Network. A Year With Family Support Network By Megan Meyer, a Former Jesuit Volunteer

When, in the summer of 2006, I began telling my friends and family that I was moving from Ohio to Montana, I surprised pretty much all of them. They were even more surprised when I said I was not getting a normal job, but was volunteering for a year with a group called the Jesuit Volunteer Corps. I would spend the year at Family Support Network, working with families at risk for abuse and neglect and

families with a child with mental illness.

Before I began working with FSN I had many preconceived notions about the families I would be working with. I wondered how anyone could mistreat a child like that. I suspected that there must be something different, something terrible, about the people we worked with. I wondered if the parents could really love their children the way I thought parents (cont. page 2)

Legislative Summit

In February, Nancy Farrar observed the budget planning process for both children and adult mental health at the Mental Health Legislative Focus Summit hosted by the Mental Health Oversight Advisory Council (MHOAC). The panel included representatives from MHOAC, the regional Service Area Authorities (SAA), judicial and law enforcement, Children's Mental Health Bureau, Kid's (cont. page 2)

were supposed to. However, as I began working with clients and seeing first hand, the interactions between parents and children, I realized my clients were people I could imagine hanging out with if their lives or mine had gone just a little differently. In the face of all my suspicions, my clients continually showed me that the things they had done to lose their children were not the defining points of their character, as I had assumed.

I began the year by dismissing FSN's clients as people who were different from me, who did things that I would never consider doing. Once I grew to know them, however, I realized that I could not condemn them out of hand the way I had when I began the year. Despite significant differences in our upbringing and lifestyles, my clients were people similar to me, with many of the same thoughts and emotions. Now that my year is completed, I miss my clients, but I am so grateful that even for a year I was able to get to know

Montana hospitals, Consumer organizations including CALM4US, NAMI-MT and the Mental Health Association of MT, Dept. of Corrections, Legislators and County representatives.

The summit's purpose was to establish an early consensus on mental health funding priorities that will be presented to the Department of Public Health & Human Services (DPHHS) budget process. The panel listed the following funding priorities for both the children and adult sector: locally based secure treatment beds, transportation, crisis intervention programs and training, workforce development,

increase state capacity in areas of tele-psychiatry, number of professionals and para-professionals working in the state, transition services youth to adult system, follow-up aftercare including medication follow-up, and flexible funding. Additional areas of concern for the children's sector included early identification, family and peer supports and mental health services to all who need it.

The Summit also identified several legislative issues that need to be addressed in the '09 legislature. These include: uniform diagnoses between children and adult systems, revision to commitment law, Medicaid Waiver, family of one status as is the case for physical and developmental disabilities, and legislative incentives for work force capacity building.

Time was allotted for public comment and interested observers were allowed to circulate among the panelists and engage them in discussions during breaks. The summit was successful in securing a broad array of voices, involvement and understanding in the beginning stages of the '09 legislative planning process.

Defensive Driving Course

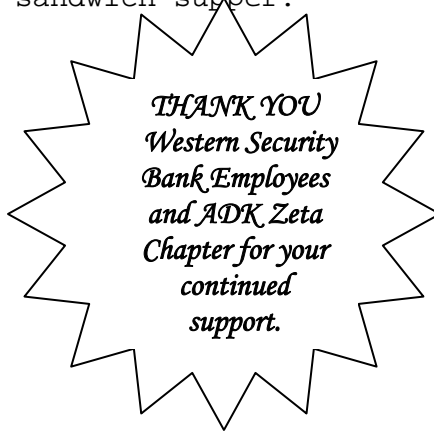
FSN employees participated in the Montana Dept. of Administration Risk Management Defensive Driving Course in March. The coursework involved lecture, visual aids and class participation. The course stressed the dangers of the distracted driver. In Montana 17,000 crashes resulting in 476 million dollars in damage is attributable to distracted drivers. Some of the most common distractions include drowsiness, cell phone usage, other riders, inattentiveness, and secondary tasks.

The response by the staff was overwhelmingly positive. As one staff member stated, "The course was a good reminder of our responsibility to pay attention to our driving to protect the children we are transporting and ourselves. The reminder to have at least a three second following distance in the city and a minimum of five seconds following distance for highway distance helped make me more aware of just what it takes to stop a car at different driving speeds."

FSN plans to make this course an annual requirement for staff training and encourages anyone who drives as part of their job to attend a defensive driving course. A yearly reminder of the dangers of distracted driving, along with tools to help reduce distractions and stay focused on one's responsibility to drive safely will help promote year long good driving practices.

Light of Hope Event

On Saturday April 19, 2008 the 5th annual Light of Hope event will host a carnival on the west side of Rose Park from 3:00 pm to 5:00 pm. Because April is Child Abuse Month, this event plans to focus community awareness on the many prevention and intervention services working to prevent abuse and neglect in Yellowstone County. "To Shine the Light of Hope" for abused and neglected children, the event will end with a short program, guest speaker, candle lighting ceremony and a sandwich supper.



THE MISSION OF FAMILY SUPPORT NETWORK

FSN recognizes that children are the foundation of the future and the family, as a basic unit of society, is the natural environment for the growth and development of all of its members. Realizing the enormous difficulties and responsibilities facing parents in today's society, Family Support Network seeks to provide intervention, support and assistance to children diagnosed

with a mental illness and their families and to those children and their families at risk for abuse or neglect.

Family Support Network recognizes the importance of parents in the lives of their children and seeks to help them access appropriate support and services and educate them in appropriate and nurturing parenting techniques.

Created in 1989, Family Support Network (FSN) provides services to 200 families in Yellowstone, Big Horn, Musselshell, Carbon and Stillwater counties. Services include assisting parents to access community based services, help develop parenting and life skills, to provide a safe and stable home for their children. Families are referred to the program by Department of Public Health and Human Services child protection staff, Maternal Child Health, Early Childhood Intervention, local physicians, and area schools. Referrals are based on suspected or known risk factors such as mental illness, poverty, inadequate housing, social isolation, education level, domestic violence, substance, physical or sexual abuse, serious emotional problems, poor parenting, and prenatal risk factors.
